# An Integrated and Comprehensive Strategy

Last week I participated in a panel of mayors at the Pace Land Use Law Center's Affordable Housing Summit. During his keynote address that morning, County Executive

George Latimer spoke of the County's consideration of a Housing Needs Assessment. I was pleased to be able to share Ossining's experience of our process on a Village level, and how we are now working on implementation.

The Village Housing Needs Assessment was conducted at the urging of affordable housing advocates. The resulting Policy Framework recommendations are designed in an evidence-based, comprehensive and sequential manner. The first recommendation is to establish a clear economic development strategy. The second is to address safety concerns by effective implementation of code enforcement. Folks who participated in last year's Housing Needs Assessment public sessions may recognize Kevin Dwarka in the above photo. He was the panel facilitator for last week's discussion. I noted that one of the challenges we are finding in our implementation of these recommendations is an eagerness to jump ahead on the list. I am increasingly recognizing the wisdom of the methodical comprehensive approach recommended in the study. Click here to further explore the Housing Needs Assessment Policy Framework.

Polic Strategy #8 is the Emergency Tenants Protection Act (ETPA). This rent stabilization program has generated significant discussion among community members. To assist folks interested in learning more about this particular strategy, we have posted ETPA FAQs on the Village website. This resource highlights a portion of the Housing Needs Assessment report, as well as an update on related Village Board actions.
