#### Public Hearings at this Week's Village Board Meeting

<u>This week's meeting will begin with two Public Hearings</u>. The first proposes changes to the noise ordinance which would limit the use of gas powered leaf blowers. <u>This proposed legislation</u> has been drafted in response to concerns raised by homeowners and environmentalists. We have

heard from a number of interested parties with a range of concerns regarding small businesses, safety, health, and quality of life. There are currently 14 Westchester municipalities that have similar legislation already in place. The second Public Hearing is regarding a proposed community residential home intended for four adults with developmental disabilities. All are welcome to comment on either topic for up to four minutes.

Corporation Counsel Stuart Kahan has been busy this year crafting legislation on a number of fronts. This week the Village Board will be voting on proposed Local Law 9 regarding dog tethering. You may recall at the Public Hearing there was a suggestion that we review legislation passed recently by the state of New Jersey. At last week's Work Session we reviewed our proposed legislation. It was informed by Corporation Counsel's review of similar legislation across NYS, and we have now compared it to the NJ code and determined that our approach achieves the same goals of protecting dogs in our community, with parameters that best suit the intention. <u>Click here to view last week's Work Session discussion</u> regarding this proposed local law.

Because this week is a Legislative Session, following the Public Hearings referenced above, there are a number of invitations for community members to comment. If you would like to spread the word about an upcoming event, please take up to two minutes during Organizational Announcements. Folks who would like to comment on the resolutions included on that night's agenda may do so for up to four minutes at the start of the Village Board Resolutions portion of the meeting. The meeting closes with an invitation for community members to comment for up to three minutes during Visitor Recognition about any topic of relevance to the common good of the Village. Also happening this Wednesday will be two NY Harbor Storm Surge Barriers Scoping Meetings. The meetings will be held at the Westchester County Center from 3-5PM and 6-8PM. This is a critical time to speak out before the comment period closes on November 5. You may recall that the Village passed a resolution clearly stating our opposition to short-sited proposals from the Army Corp of Engineers which would have a detrimental impact on Hudson River communities like Ossining.
