#### **Proposed Code Revisions on Housing**

At this week's Work Session, Corporation Counsel Stuart Kahan will be leading us in a discussion of two proposed code revisions related to housing conditions in the Village. The potential for introducing additional instances of confirming a property has a Certificate of Occupancy, is one approach that has been implemented in other municipalities in addressing the challenge of overcrowded housing. We will also be looking at moving forward two of the recommendations presented by the Landlord Tenant Relations Council subcommittee.
