# Village of Ossining Historic Preservation Commission Essay/Video Contest

#### **Contest Details**

For generations, African Americans have played an important role in the history of the Village of Ossining, but too often that history, and the places significant to it, have been overlooked. Numerous sites, structures, and neighborhoods in the Village of Ossining embody the history of Black contributions to the community and resilience in the face of oppression.

In an essay or video, describe a site, structure, or neighborhood in the Village of Ossining that represents important aspects of Black history in the Village. Your essay or video should:

(1) Describe the architecture, design, or layout of the site, structure, or neighborhood;

(2) Explain the significance of the site, structure, or neighborhood to local Black history; and

(3) Describe the ways in which making a video or writing about the site, structure, or neighborhood has changed your perception of it.

## Deadline

## Rules

- Entrants must be currently enrolled in the 9<sup>th</sup>, 10<sup>th</sup>, 11<sup>th</sup>, or 12<sup>th</sup> grade at Ossining High School.
- Entrants must prepare a cover sheet including their name, grade, mailing address and/or email address.
- Entrants must include a bibliography citing a minimum of two (2) sources.
- Essays must be no fewer than 500 words and no more than 1000 words.
- Videos must be no less than 3 minutes and no more than 5 minutes.
- Videos must not use copyrighted material without permission of the copyright holder, and must not use footage of third parties without the third parties' permission.
- Essays and videos may be produced by teams of or two or more students. However, each student is limited to one entry.
- Essays and videos may be in English or Spanish.
- Essays and videos will be judged based on depth of historic and architectural research, organization and style, and adherence to contest guidelines. See Rubric below.
- Essays and videos must be the original work of the student(s).
- HPC may reproduce, distribute, or exhibit winning essays or videos on its website, at conferences, or in publications.
- By participating in the contest, entrants agree to be bound by and to accept the terms and conditions of these Rules.
