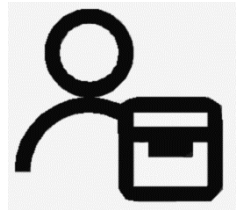

A Hawking and Peddler's License shall not be assignable. Any holder of such license, who permits it to be used by any other person, and any person who uses such license granted to another person shall be guilty of a violation of this Ordinance.

It is agreed by the applicant that he/she will conform with all the rules and regulations of the Village of Ossining governing the issuance and use of a Hawker's and Peddler's License.
