

# LOCAL LAW NO. 7-2015

## VEHICLES AND TRAFFIC LAW REVISION

A LOCAL LAW amending Chapter 250 of the Village Code of the Village of Ossining entitled "Vehicles and Traffic" to reiterate and clarify on-street parking regulations along various streets in the Village, including Van Cortlandt Avenue and Wolden Road.

BE IT ENACTED by the Board of Trustees of the Village of Ossining, as follows:

Section 1. Section 250-49. Schedule XII "Parking Prohibited at All Times" is hereby amended as follows with new matter underlined and deleted matter in [brackets]:

Name of Street	Side	Location
<u>Van Cortlandt Avenue</u>	<u>South</u>	<u>Entire Length from North Highland Avenue to end</u>
[Van Cortlandt Avenue]	North	From North Highland Avenue to a point 58 feet east thereof
<u>Van Cortlandt Avenue</u>	<u>North</u>	<u>From a point 361 feet east of North Highland Avenue to Cortlandt Place</u>
Van Cortlandt Avenue	North and West	From Cortlandt [Avenue] <u>Place</u> to a point [120] <u>40</u> feet [northwest] thereof

Section 2. Section 250-62. Schedule XXV "Streets Designated for One Side Overnight Parking" is hereby amended as follows, with new matter underlined and deleted matter in [brackets]:

Name of Street	From	Location To
Linden Avenue <u>(east side)</u>	[Clinton Avenue] <u>Ellis Place</u>	Croton Avenue
Linden Avenue <u>(west side)</u>	Glen Street	Dale Avenue
Van Cortlandt Avenue <u>(north side)</u>	North Highland Avenue	northeast 1200 feet <u>(except as prohibited in Schedule XII)</u>
<u>Wolden Road, east side</u>	<u>a point 58 feet north of Underhill Road</u>	<u>a point 200 feet south of Overton Road</u>
<u>Wolden Road, east side</u>	<u>a point 20 feet north of Overton Road</u>	<u>to Ellis Place</u>

Section 3. Section 250-62. Schedule XXV "Streets Designated for Alternate Side Overnight Parking" is hereby amended as follows, with new matter underlined and deleted matter in [brackets]:

Name of Street	From	To
[Linden Avenue]	[Clinton Avenue]	[Ellis Place]

Section 4. Section 250-55 Schedule XVIII "Time Limit Parking" is hereby amended as follows, with new matter underlined and deleted matter in [brackets]:

Name of Street	Side	Time Limit: Hours/Days	Location
Croton Avenue	South	1 hour; 9:00 a.m. to 7:00 p.m./All days Except Sundays and Holidays	From Clinton [Place] <u>Avenue</u> to Palmer [Avenue] <u>Place</u>

Section 5. Except as otherwise provided herein, all other provisions of Chapter 250 "Vehicles and Traffic" shall remain the same.
